## NOTIFICATION

No - 813 / (Syllabus)/ Dt - 23/05/2023

In continuance to this Office Notification No- 334/(Syllabus)/ Dt- 20/02/2023 and pursuant to Letter No- 12494/ SME/dated- 20/05/2023 of the Department of School and Mass Education, Govt. of Odisha, it is notified that the Assessment Pattern for HSC & Madhyama Courses in both classes IX & X to be implemented from academic session 2023-24 and onwards will be as follows:

1. Internal Assessments will continue as usual which will be conducted in the form of four Formative Assessments, one in each quarter.
2. At the end of the year, one Summative Examination will be conducted with 100 marks in each subject for HSC course, out of which 50 marks will be Multiple Choice Questions (MCQ) and rest 50 marks will be subjective in nature.
3. One year ending examination will also be conducted for Madhyama course, out of 100/75 marks having 50/40 marks of MCQs and 50/35 marks of subjective questions.
4. The pattern of questions with distribution of marks for the examinations will be notified soon.
5. Similar procedure will be followed for Class - IX, in both the courses i.e., HSC & Madhyama. However, for the year-end examination of Class IX and half yearly examination of Class X, Board will prepare the question papers and supply the same to the District Education Officer of each district. The District Education Officer will further supply the question papers to each school. The examinations will be conducted under the direct supervision of concerned District Education Officer. Questions will be supplied to all the schools of the State to maintain uniformity in the examination. The processing & publication of results will be done at the school level. The date of examination will be notified by the Board.
6. There will be provision of supplementary examinations for HSC Course only after the year end examination as per the previous practice.
7. Aspirational components would also be part of the internal assessments.
